**What size of skip** -It can be difficult deciding what size of skip you will need for all that waste you have piled up, so you are welcome to visit our Felspar Road, Amington, Facility during office hours to discuss and view the sizes of skips available with our customer service team, ensuring you choose the right size skip for the job, but please remember skips can only be filled to the maximum level of the sides of the skip!

**What Our Costs Include** -Our prices include VAT and are for skip hire for dry non hazardous waste including container rental for up to seven days, beyond this period a rental charge of £2.40 per day will be applied. Your skip will be automatically collected after seven days unless you call us the day before requesting and paying for an extension to hire. All skips placed on the highways shall be collected the same day. Any skip placed on the Highway or public space shall require a County Council Highways permit to which with administration costs will be an additional £36.00 (No VAT) in addition to the cost of the skip.

**Payment**- must be made prior or up on delivery of the skip, this can be done by credit or debit card over the phone when ordering.

**Cancellation Terms** – If the Hirer chooses to cancel the hire, a 10 % charge based on the gross cost will be levied in order to cover administration costs and bank charges. We are unfortunately unable to refund County Council highway permit charges.

**Highway , Public space-** If the skip is to be placed on the highway or on council property then a Highway Agency permit has to be obtained. These are obtained from the Highways Agency on your behalf at a cost including administration of £36.00. The Highways Agency require seven working days notice in order to allow them to visit and view the site where the skip will be placed, therefore a permit is not guaranteed. Skips can only be placed on the highway for the day and shall be left with cones and possibly lights which you the hirer will be responsible for.

**Delivery** -We endeavour to offer a four hour skip delivery slot either between 8am and 12pm or 12pm until 4pm Monday to Friday. But as we cannot foresee what delays our drivers may encounter from traffic jams, accidents and other problems we cannot be held responsible for the odd occasion we may be late.

**Waste-** The skips are for dry non hazardous waste only and a list of acceptable waste streams is attached. If you are uncertain regarding any waste please do not hesitate to call us. A few common wastes are now deemed hazardous waste and must be collected and disposed of separately. We are happy to quote and advise our customers who have these types of waste.

**Recycling-** It is estimated that by 2018 there will be virtually no landfill space left in Britain and therefore the government continues to increase landfill tax annually, to which shall rise to £88.95/tonne plus vat per tonne by April 2018. Waste management companies have to pay this as well as a disposal cost on waste sent to landfill.

**TERMS OF SKIP HIRE SERVICE**

**THE COMPANY TERMS & CONDITIONS OF TRADING ARE AVAILABLE SEPARATELY ON REQUEST**

**UNDER THE ENVIRONMENTAL PROTECTION ACT 1990 SECTION 34 YOU ARE REQUIRED BY LAW TO DECLARE THE TYPES AND QUANTITY OF WASTE BEING REMOVED FOR DISPOSAL/RECYCLING. THE SIGNING OF THE CONTROL WASTE TRANSFER NOTE INDICATES YOU HAVE READ AND UNDERSTOOD OUR COMPANY TERMS OF SKIP HIRE SERVICE, AGREE TO ABIDE BY THEM ALONG WITH OUR COMPANY TERMS & CONDITIONS OF TRADING AND THAT YOU HAVE DISCHARGED YOUR DUTY IN RELATION TO REGULATION 12 OF THE WASTE (ENGLAND AND WALES) REGULATION 2011.**

- ALL CONTAINERS MUST BE LOADED SAFELY AND EVENLY TO A MAXIMUM LEVEL OF THE SIDES OF THE CONTAINER AND WITH IN THE CONTAINER, ANY BREACH OF THIS, THE WASTE WILL BE SUBJECT TO OUR DISCRETION, BE REMOVED PRIOR TO COLLECTION OR CHARGED AS A LARGER CAPACITY SKIP.
- NO RUBBISH SHALL BE BURNED BY OR IN THE CONTAINER
- NO WET CONCRETE, MORTAR OR LIQUIDS SHALL BE PLACED IN CONTAINER
- LIABILITY FOR DAMAGE TO ROADS ETC. IF A SERVICE IS REQUIRED BY THE CUSTOMER INVOLVING VEHICLE
- MOVEMENT OTHERWISE THAN ON THE PUBLIC HIGHWAY THE CUSTOMER SHALL AFFORD REASONABLE SAFE AND ADEQUATE ACCESS AND SPACE IN WHICH LOADING AND UNLOADING OPERATIONS FOR DELIVERY AND COLLECTION MAY BE CARRIED OUT WITH OUT RISK OF DAMAGE TO THE VEHICLE OR DRIVER. THE DRIVER OF A VEHICLE PROVIDING SUCH A SUPPLY SHALL BE DEEMED TO BE UNDER THE CONTROL OF THE CUSTOMER AND THE CUSTOMER SHALL BE SOLELY RESPONSIBLE FOR ANY ACCIDENT OR DAMAGE CAUSED BY THE WEIGHT OF THE VEHICLE OR ITS LOAD OR ANY MOVEMENT OF THE VEHICLE OR ITS LOAD TO ANY BRIDGES, WIRES, CABLES, DRAINS, MANHOLES AND ANY OTHER SERVICES, ROADS, PATHS OR ANY OTHER SURFACE OR ANY OTHER PROPERTY ON ABOVE.
- THE CUSTOMERS ATTENTION IS DRAWN TO THE NEED TO OBTAIN A LICENCE ISSUED BY THE COUNTY COUNCIL TO DEPOSIT A SKIP ON THE HIGHWAY OR COUNCIL OWNED PUBLIC SPACE. THE CUSTOMER IS RESPONSIBLE FOR ANY DAMAGE CAUSED TO PAVEMENTS, VERGES OR PUBLIC SPACE. SKIP CONTAINERS PLACED ON THE HIGHWAY WILL BE MARKED WITH CONES. IT IS THE RESPONSIBILITY OF THE CUSTOMER TO ENSURE THE SKIP REMAINS MARKED AND TO LIGHT WARNING BEACONS DURING LIGHTING UP TIMES IF THE SKIP REMAINS ON THE HIGHWAY BEYOND THE HOURS OF DUSK.
- ONCE THE CONTAINER HAS BEEN DROPPED IT BECOMES THE RESPONSIBILITY OF THE HIRER AND MUST REMAIN SITUATED IN THE SAME PLACE AS TO ALLOW ACCESS. ACCESS MUST BE MAINTAINED TO AND AT LEAST A METRE AROUND THE CONTAINER THROUGHOUT THE WORKING DAY. THE CUSTOMER SHALL MAKE GOOD TO THE COMPANY ALL OR ANY LOSS OR DAMAGE TO ANY CONTAINER OCCURRING OR CAUSED DURING THE CONTINUANCE OF THE CONTRACT WITH THE CUSTOMER.  
ALTHOUGH EVERY EFFORT IS MADE TO SUPPLY SKIP CONTAINERS IN SERVICEABLE CONDITION PLEASE CHECK CONTAINER DOORS, SIDES AND FLOORS FOR DAMAGE AND THAT DOORS AND LOCKING DEVICES ARE WORKING AND THAT ALL DOORS ARE FULLY CLOSED AND LOCKED PRIOR TO REQUESTING COLLECTION.  
WE WILL BE HAPPY TO EXCHANGE ANY EMPTY CONTAINER THAT IS DEEMED AND AGREED BY US TO BE FAULTY.
- PLEASE BE AWARE THAT THOSE CONTAINERS WITH DOORS HAVE STEEL DOORS WHICH ARE HEAVY AND MAY EXCEED 25KG SO IT IS ADVISABLE TO OPEN & CLOSE THE DOOR USING TWO PEOPLE WEARING SUITABLE PROTECTIVE GLOVES AND PROTECTIVE FOOTWEAR.
- ANY DAMAGE CAUSED TO THE SKIP CONTAINER OR VEHICLE DELIVERING OR COLLECTING THE CONTAINER WILL BE CHARGED TO THE CUSTOMER. WE ADVISE THAT YOU DO NOT MOVE OR CLOSE CONTAINER DOORS WITH MECHANICAL PLANT. FAIR WEAR AND TEAR IS ACCEPTED ON SKIPS THAT REMAIN ON SITE ON HIRE FOR EXTENDED PERIODS OF TIME.
- A MAXIMUM WAITING PERIOD OF FIVE MINUTES WILL BE ALLOWED FOR DELIVERY AND COLLECTION OF SKIPS, ANY TIME ABOVE THIS IS CHARGABLE AT A RATE OF £70.00PER HOUR.
